## AFTERSCHOOL CLUB TERMS AND CONDITIONS – (please keep this sheet)

ABSENCES Refunds will not be given for non-attendance of ad-hoc bookings unless 24

hours notice if given. No refunds for non-attended contracted sessions are available. Please advise a member of staff if your child will not attend a contracted session as parents will be contacted if a child does not arrive at

Afterschool Club.

**ACTIVITIES:** Children may choose activities from a wide range of board games, ICT,

outdoor games, and arts & crafts plus there are a selection of adult led activities. Junior children have the opportunity to complete homework within the session. Children will also have the opportunity to support the

school team in any home sporting fixtures.

**ADHOC BOOKINGS**: Additional sessions may be booked at the reduced rate of £13.50 per

session but will be subject to availability.

**BEHAVIOUR:** In the event of a pupil behaving in an unacceptable manner the child will

be given a warning, and the parents will be notified.

We reserve the right to withdraw an offer of a place in the following circumstances:

Unacceptable behaviour resulting in distress or disruption to adults or

children at the club

- Where a child has not attended the club for their allocated session of 3

consecutive weeks.

**COLLECTION:** There is no parking on the school site at any time. Please ensure you park

legally around the area of the school. Children can be collected any time before 6pm. Collection is from the main school office. Please ring the mobile number provided and advise the staff of who you are collecting, and they will be brought to you, please allow a few minutes for this process.

A late collection fee of £5.00 is charged for every five minutes after 6.00pm.

Please note that ASC finishes at 5.30pm on a Friday.

**CONTACT:** Mobile phone – 3.00pm – 6.00pm only.

**FEES:** Parents will be invoiced for the whole term. Invoices should be paid in

advance either monthly, half termly or termly. Any payments received after this date will be subject to a £25.00 late fee. Where payments are not made in advance and arrears are accumulating, we reserve the right to

cancel the booking with immediate effect.

**NOTICE PERIOD:** One month's notice is required to cancel or reduce any contracted

sessions. Parents will still be invoiced for one calendar month following the date of the notification regardless of when in the month you advise us.

Increases in contracted sessions will be subject to availability.

**TEA:** Will be served at from 4.15pm to 5pm. Children can choose from either rolls

or wraps and can choose from a selection of meats, cheese and

vegetables. A selection of fruit is available at all times. Please advise of any

dietary requirements before your child starts.

TOILET TRAINING: Whilst we are able to accept children who are still in nappies into our Pre-

School we are unable to accept children into our Breakfast and

Afterschool Club until they are fully potty trained as we do not have the

staffing or facilities to accommodate this.

In the event of school closure due to critical weather conditions or emergencies, refunds will not be given. However, if you wish to book any additional sessions as compensation then these can be booked, subject to availability. **Mobile phones should not be used or seen at any time whilst on school premises.**
